MINERAL TANK

12 YEAR WARRANTY IN THE EVENT OF THE TANK BECOMES UNUSABLE BECAUSE OF LEAKAGE, CORROSION, OR RUPTURE.

ION EXCHANGE RESIN

12 YEAR WARRANTY THE MODEL AQUIAS CARRIES A HIGH CAPACITY ION EXCHANGE RESIN AND HAS A 12 YEAR WARRANTY WHEN IT IS MAINTAINED IN ACCORDANCE WITH THE MANUFACTURER'S RECOMMENDATIONS.

SALT STORAGE TANK

12 YEAR WARRANTY IN THE EVENT OF THE TANK BECOMES UNUSABLE BECAUSE OF LEAKAGE OR RUPTURE.

ALL INTERNAL COMPONENTS

ARE WARRANTED FOR 12 YEARS FROM DATE OF INSTALLATION.

CONTROL VALVE BODY

12 YEAR WARRANTY THE CONTROL VALVE BODY IS WARRANTED FOR 12 YEAR FROM DATE OF INSTALLATION.

ALL INTERNAL CONTROL VALVE PARTS

ARE WARRANTED FOR 12 YEARS FROM DATE OF INSTALLATION.

ELECTRICAL PARTS

12 YEAR WARRANTY INCLUDING COMPUTER, MOTOR, AND OTHER ELECTRONIC COMPONENTS

CONSUMABLE GOODS

ITEMS SUCH AS: FILTERS, CARBON FILTER, CARBON, NORMALLY WEARABLE ITEMS (CONSUMABLE GOODS) ARE NOT COVERED UNDER THIS WARRANTY AND SHOULD BE REPLACED AT REGULAR INTERVALS AT THE OWNERS EXPENSE PER THE MANUFACTURES INSTRUCTIONS TO MAINTAIN THIS WARRANTY.
